William D. Ford Federal Direct Stafford Loan Program Information

SUMMER ONLY APPLICATION

The William D. Ford Federal Direct Stafford Loan is a loan used by many students to help finance the cost of higher education. The following information explains what you need to do in order to receive your Federal Direct Stafford Loan.

Application Procedures for All Borrowers

1. File a FAFSA at <http://www.fafsa.ed.gov>
 - PVCC School code **009928**
2. Complete **Section A** and **Section B** of the PVCC Loan Request Form (student Direct Stafford Loan)
3. Go to <https://www.studentloans.gov>
 - Completing **online Entrance Counseling** and
 - E-signing your **Master Promissory Note (MPN)** with the Federal government via the U.S. Department of Education.
 - **Print** confirmation page for both Entrance Counseling and Master Promissory Note and turn in with loan request.
 - You will need **your Federal FAFSA Pin number** and PVCC Federal Direct code is G09928.
4. Return completed Loan Request Form to:

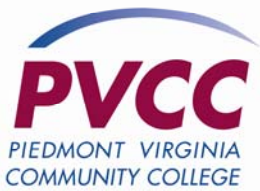
Apply early – by March 1st to be awarded before each summer semester starts.

Students applying late will be processed in the order the loan requests were received. Normal processing time is 4-6 weeks.

PLEASE REMEMBER TO:

- Put your student ID number on the Loan Request Form
- **Respond promptly to requests for information.**
- Never borrow more than absolutely necessary.
- **Total Loans must be repaid plus Interest**
- Remain enrolled in 6 or more credits all semester to receive loans and avoid repayment.
- All loans will be disbursed in two disbursements – usually fall/spring – or two different times per semester.
- Stafford Unsubsidized Interest Rate is 6.8% (Subsidized Rate is 4.5%)
